#### 1. White Book, 2021 Edition / Implementation Stage

#### **Total proposals (113) from the White Book 2021:**

- **35** are already implemented and used in practice,
- 63 are in the implementation process,
- 15 not accepted,

As a result, **87% of our proposals** were accepted by the authorities.

#### The implemented proposals:

- ✓ Implementation of the regular external evaluation of judges,
- ✓ Exclusion of the "judicial mediation" procedure,
- ✓ Acceptance of social benefits for foreign citizens who do not pay social insurance in Moldova,
- ✓ Cancellation of informative boards with general access to company premises,
- ✓ The application of the probationary period for persons hired based on a contest,
- ✓ Suspension of the individual employment contract in circumstances beyond the control of the parties (if the employer has no information about the reason for the absence),
- ✓ Exclusion of reporting on military records of employees,





#### 1. White Book, 2021 Edition / Implementation Stage

#### **Total proposals (113) from the White Book 2021:**

- ✓ Regulation of the Non-compete clause in Labor Code,
- ✓ Exclusion of the trade based on patents,
- ✓ Law on prevention of food waste approved,
- ✓ Recognition of digital signatures of trusted providers,
- ✓ Implementation of cashless payment for government services, using POS terminals,
- ✓ Regulation of the producer prices for local medicines (amendment of GD 525/2010),
- ✓ Setting up penalties for denying access to reservoirs for other water users,
- ✓ Simplification of access to cadastral services regardless of location,
- ✓ Abolition of the "2.5%" luxury tax,
- ✓ Abolition of the portability fee,
- ✓ Remuneration for private copying (approval of a new law),
- ✓ Reform of personal data protection legislation (GDPR Law),
- ✓ Merger of ANRCETI functions with SNMFR,
- ✓ Simplification of authorization procedures for telco network construction,
- ✓ Amendments of legislation on gambling,
- ✓ etc.





#### 2. FIA 20th Anniversary & White Book, VIII-th Edition's Official Launch

On 25 October 2023, FIA celebrated its 20th Anniversary and presented the eighth edition of the White Book, which consists of 9 chapters including 115 proposals to improve the investment climate, prepared in accordance with the National Development Strategy "European Moldova 2030". The structure of several chapters, such as Labor Relations, Transition to Green Economy, Digital Transformation, has been revised and the chapter on the Telecom Industry – where the majority of recommendations have been implemented - was removed from the new edition.






Investiții Directe: acumularea netă de pasive, pe instrumente (milioaneUSD)

## 11. FIA Members CSR common Project

In February 2023 FIA executive direction have invited members to join another initiative - to make a contribution to the Centre for the Elderly and Disabled People in Criuleni. We started a members' common campaign and due to our members significant donations, we managed to build 4 greenhouses and a pergola, in different villages (Criuleni, Chisinau, Cocieri and Sarata Galbena).

The project was implemented by "Fabrica de Fericire" NGO, founded by Steluta Andreeva.











#### 11. FIA CSR Project

Starting 2020, FIA Board of Directors accepted and decided to implement the Association's own CSR project every year.

In august 2023, there was inaugurated a greenhouse in Riscani, where the residents are able to grow their own vegetables and feel useful by being involved in these activities.

The project is in line with UN's SDGs and ESG indicators and is part of Foreign Investors views on sustainable development of the country.

The Complex, located in Riscani district and founded in 2013, has a few areas of activity: Phoenix Day Center that brings together 37 children with special needs from 10 localities and a the Center for early intervention — around 200-300 children yearly.

Until the end of 2023 year, there will be inaugurated another greenhouse in Puhaceni, Anenii Noi district, for 30 residents.


